Chief and Committee Reports

The Chief's Report was presented by Dep. Chief Evans – See full report for details. The following items are noted:

- There were five lateral new hires that began February 5th: Two Firefighters, Two Paramedics, and One EMT. There was one resignation.
- Firefighter Ryan Loveall was promoted to Sergeant to fill the vacancy from Sergeant Alex Nagel's move from Fire to EMS.
- o The surplused Quint was purchased for \$15,000 by Vine Grove Fire Department.
- Fire Prevention Documents have been prepared and sent to the Jefferson County Attorney's Office in regards to the Brown Suburban Building's failure to comply with fire regulations.
- Update given regarding Differential Pay. The new policy went into effect February 4, 2024 and will be reflected in the upcoming paydate February 23, 2024.

Deputy Chief Early commended Major Reef for her efforts with the Resuscitation Quality Improvement (RQI) Program. Improvements have been measured in all areas of training and testing and her efforts are noted and appreciated.

District Chiefs Dwyer and Recktenwald, Assistant Chief Hutchens, and Major Burd had nothing to report.

New Business

Motion Deloch, 2nd Ash to update the EE Handbook 301 'Paid Time Off' as presented. MC unanimously. The changes will go into effect March 1, 2024 and be retroactive to include new hires.

- Motion Ash, 2nd Pierce to update the EE Handbook 300 'Holidays" as presented. MC unanimously.
- Motion Ash, 2nd Pierce to approve Roger Cecil's (Resignation in January) as a Lifetime Member, having served as a Volunteer and Career Firefighter, EMT, Paramedic, and EMS Chief, since April 4, 2000. MC unanimously.
- Motion Pierce, 2nd Ash to: Surplus a boat trailer and 3 Ford Expeditions; Donate the boat trailer to a department in need; and Accept sealed bids for the Expeditions with minimum bid of \$6,000-\$6,500 each (to be determined by James Sebastian before notice of bids). If minimum bids are not received, the vehicles will be sold to CarMax. MC unanimously.
- It is noted that the Appointed Board of Trustee position held by Susan Pierce and the Property Owner Board of Trustee position held by Chuck Bauer are expiring June 30, 2024. A letter to the Mayor to inform of the expiring Appointed position was signed by Secretary Ash.
- Motion Ash, 2nd Pierce to spend \$109,000 (includes deductible) of budgeted funds, for a new chassis for the Braun ambulance that is currently in repair shop due to accident at Hurstbourne and Bardstown Road. MC unanimously.
- Motion Ash, 2nd Deloch to refund \$5,000 to the Rutledge Volunteer Fire Department in Tennessee that was received for the purchase of the surplused Seagrave Engine and donate the Engine to them, due to their limited resources and needs. MC unanimously.
- Motion Ash, 2nd Pierce to purchase accordion dividing wall for St. #71's (Fegenbush Lane) Training Room for \$24,600 with budgeted funds. MC unanimously.
- A reminder was given for the upcoming Awards Banquet on February 24, 2024.
